Basic Definitions



1 – Concepts & goals of the project:

The National Renaissance Project represents a theoretical and practical cognitive frame to take the nation out of its current state which is characterised by a deflation of morale, political grouping, intellectual scattering, longwinded divisions, meaning & role, function, where its symptoms and outcomes withdraw wasted energy, absent roles and aborted dreams.

Thus, the National Renaissance Project stands out, a curriculum, a vision and a direction that rises above the divisions and fabricated contradictions, seeking to bypass basic hurdles in order to come out with a common vision and collective efforts and several branches that all converge into one current, its only goal is establishing a viable base to build a sustainable national renaissance and to confront the hazards and threats that await the nation and humanity.

Accepting multi branches, visions, efforts and interpretations is a sign of good health, actually, it is a fertile soil; where the goal is to diagnose national practices that are responsible and responsive to high national interests. Devoid of self-parochialism for any individual or direction or doctrine or race or current or party or authority. Both its guide and tempter is Arab and national interest, especially human rights, the Arab human in particular. Thus the project does not represent a departure from the Qatari interests, nor its presence or survival. It confirms the importance of the Qatari state within the frame of its national belonging, and this was practically translated by inviting the Arab governments to participate with whomever they designated from their cadres, in producing a new Arab condition, side by side with wide circles or national intellectuals and proponents of liberty, justice and peace within the frame of the project which opens its doors and windows completely to every dialogue, interpretation and addition to overcome a huge accumulation of frustration, that represents in itself, the greatest and gravest threat.



2- Organisational framework

First: National Renaissance Council

The National Renaissance Council is composed of 207 members covering the five Arab regions:

1. Levant Syrian Region (Syria, Lebanon, Jordan, Palestine, Iraq and the Kurdish people who have lived on its lands historically in the Middle East and its territories).
2. Arabian Gulf region (Kingdom of Saudi Arabia, Kuwait, United Arab Emirates, Qatar, Bahrain, Oman).
3. Nile valley region (Egypt & Sudan).
4. Yemen & West of Red Sea (Yemen, Comoros Islands, Djibouti and Somalia)
5. Arab Morocco (Libya, Tunis, Algeria, Morocco and Mauritania)

Second: National Renaissance committee

The National Renaissance council shall elect a National Renaissance committee which will be a monitoring and executive committee for most of the resolutions the council issues or approves.

Third: Scholars council

A scholars council will be formed from individuals, all Arab countries recognize equally. The council shall play a strategic role to support and develop the National Renaissance Project where the National Renaissance resolutions and the Renaissance committee resolutions are proposed for validation or amendment. Also, the council is empowered with issuing national resolutions necessary to push the National Renaissance Project forward.



Fourth: Specialist Committees

The Renaissance council, from its members, shall form committees concerned with most of the affairs that are within the circle of national interest. The proposed committees are:

1. Human Rights Committee.
2. Ideological Organisation & preparation committee.
3. Dialogue in foreign policy committee.
4. Dialogue in Arab internal policy committee.
5. Dialogue for establishing an Arab common market committee.
6. Dialogue for the liberation of the occupied Arab territories committee.
7. Constitutional dialogue and patronage committee.
8. Dialogue for achieving Arab-Arab reconciliations and overcoming conflicts.
9. National Renaissance Project development & monitoring committee.
10. Qatari dialogue committee for security, independence and preparation of Qatari Arab states and maintaining their independence and work on helping Arab states achieve security, growth and independence.
11. Committee for work on achieving Arab democracy.
12. General National liaison committee to work and assist in developing the National Renaissance Project in nationalities and states that need Renaissance work and its continued development except for nationalities or states that occupy the land of others so that this will achieve humane nationalism.
13. Dialogue committee to establish a national league for the Arab peoples to coordinate with Arab governments to assist in achieving the National Renaissance Project which is before us.
14. Legislation & laws committee to crystalize the projects of different laws to propose to the scholars council so that after they are validated they are proposed to the Arab peoples and governments for familiarisation and discussion and taking what is necessary from the resolution so that everyone is accountable before God and history and generations in a message of contemporary history that prevents devolution and records what dialogue and practice took place and issuing the resolution and having the will to do so.
15. Women's rights committee.



16. Finance committee which is subject to the monitoring from Arab governments via their representatives in the Renaissance council. Money is obtained through Renaissance members who hold a membership card (member of the National Renaissance Project) which is equivalent to the Pound Sterling and from able contributors and outside the Renaissance project.
17. Environmental research committee.

Fifth: President of the Scholars Council

The Renaissance council shall elect a president of the Scholars council.

Sixth: Organisational Rules

1. The Renaissance council shall implement the bylaws.
2. Any Arab government may send a representative to the National Renaissance Council to be represented in it, in its committees and in its scholars council to contribute in establishing the integral Renaissance work between the Arab governments and the Arab peoples.
3. Any regime may engage in dialogue with the National Renaissance Council as it does not interfere with the domestic affairs of any Arab state.
4. Any Arab and non-Arab citizen residing on Arab land may nominate themselves or others to this council providing the matter is settled by voting via fax or email or the National Renaissance website.

National Renaissance Project



Within the frame of a responsible intellectual forum, those intellectuals converged to hold numerous meetings of dialogue for over 3 months, the research and dialogue concentrated on our national concerns and differing political tendencies. We arrived, by our modest efforts, to what we present to the Arab national, and to all nationals in the Middle East, irrespective of their diverse ethnicities, allegiances, location, politics, responsibility and nationalism. We pray that we have infused in what we present to you a sliver of hope and contemplation through our efforts, praying for grace if we were right and forgiveness if we were wrong.

We wish to confirm, from the start, that this is not directed against anyone on this earth. Thus we send it via the Arab News Network, drawing attention that it is directed to the peoples of the middle east, in particular the Arab people who suffers from division and loss in these hard times, and which calls to those around it to care for itself and those around it in order to avoid the Arab world many woes, should everyone procrastinates delivering his patriotic message which is waiting for everyone to exert efforts and persevere for an early renaissance and before it's too late.

Thus, we called our project "The National Renaissance Project", aiming, once more, to our Arab people as this does not touch on existing regimes, but calls them to contribute to achieve this project away from its consuming institutional frames, which had brought us to where are now; divided, scattered and lost. We, confirm the importance of the Qatari state in the frame of its national affiliation translating thus, a real national practice on the route to unifying Arab interests and Arab human rights and that we, the Arabs, would have individuals, groups, a gauge to measure responsible national practice so that all can be witnesses during their life and before God, and give a true testimony away from the abyss, and in science that enables work within the conditions of the available transparency in every Qatari Arab nation via practicing liberty within the frame of liberty & justice & peace.

We wish, lastly, that the Arab governments help by contributing some of their cadres who are suitable to produce what can be produced.

We can only, in this occasion, but wish that the change would encompass the Arab League, where it would change its constitution and bypass what its



name had left behind, frustration for the Arab man; where we resorted, in our work ethic, to a simple imagining that launches in its light responsible dialogue that develop it and evolve it to take from and give to it, mature it with its powers of nurture in expediting its movement through faith in God and nationalism. How we wish to have given what's beneficial to our people and official governments and to all the peoples and governments of the world.

Here, we are discussing the "National Renaissance Council" which does not interfere with the intricacies of matters but concentrates on issues within the realm of basic issues for Arab peoples, in practice, application and production to achieve national dimension exceeding all forms for cultural, intellectual and political tendencies.

We are aware that nationalistic intellectuals and proponents of liberty, justice and peace everywhere will contribute to this dialogue via suggestions to develop the intellect and crystallising methods to increase the yield of our national work to serve our higher interests and raise the contribution levels of our Arab peoples in developing and raising the levels of all other peoples that share our faith in national humanity.

17. Environmental research committee.

Before the bylaws are phrased by the National Renaissance Council, a number of organisational rules must be referred to:

First: Headquarters: The headquarters for the National Renaissance Council shall be wherever the members reside.

Second: Conferences and meetings shall be conducted via telephone, fax and electronic medium wherever the members exist inside or outside the Arab homeland.

Third: Committee heads shall congregate wherever the president of the National Renaissance Council and his deputies reside.

Fourth: The National Renaissance Council shall form the National Renaissance committee from national personalities irrespective of their political affiliations, as well they can be from opposition or Arab governments.

Fifth: Work on these structures shall cease whenever the National Renaissance Project develops a renaissance project in the Qatar state.

Sixth: The Council is deemed as a National Renaissance Committee and enjoys independence in decision making, follow up and execution.

Seventh: The National Renaissance Committee shall elect a National Renaissance Committee as a follow up and execution committee for most resolutions issued or validated by the council.

Eighth: A scholars council will be formed from individuals, all Arab countries recognize equally.



Ninth: Any Arab government may send a representative to the National Renaissance Council to be represented in it, in its committees and in its scholars council to contribute in establishing the integral Renaissance work between the Arab governments and the Arab peoples.

Tenth: Any regime may engage in dialogue with the National Renaissance Council as it does not interfere with the domestic affairs of any Arab state.

Eleventh: Any Arab and non-Arab citizen residing on Arab land may nominate themselves or others to this council providing the matter is settled by voting via fax or email or the National Renaissance website.

Twelfth: The council shall play a strategic role to support and develop the National Renaissance Project where the National Renaissance resolutions and the Renaissance committee resolutions are proposed for validation or amendment. Also, the council is empowered with issuing national resolutions necessary to push the National Renaissance Project forward.

Thirteenth: The Renaissance council shall elect a president of the Scholars council.

Fourteenth: All entities of the National Renaissance Project is open to all of the components of this region of nationalities to achieve its own national renaissance providing that some nationalities relinquish occupied territories and return rights to their rightful owners.

Finally, we wish to confirm that the National Renaissance Project is limited to anyone, but it is open to all Arabs and non-Arabs in the middle east and all the leaders in the area and it is not closed or rigid, but it is suited for the beginning of a comprehensive dialogue on the background of the National forum to unite national humanity theory.

The National Renaissance Project shall be distributed to Arab governments and news agencies where it forms a start and a launch for development and renaissance. We wait from those with ideas that can be added to this project or those who have suggestions to omit from it to send them to the Arab News



Network to be added to the dialogue which enables the interim Council of Scholars to consult with it and discuss it.

The dialogue in this project shall have 3 months, after which the affiliation to the Project shall begin. This Project does not obligate anyone during the dialogue nor will it be affiliated with anyone. It is the project of all of those who are participating in the dialogue or affiliated with it, those are considered, within six months, after the first 3 months or dialogue, the founding members of the Renaissance Project.
